Re: Informational Notification regarding MCC Telephony of Florida, LLC; Notice of Pro Forma Transfer of Control

MCC Telephony of Florida, LLC's (MCC) parent company, Mediacom Communications Corporation, announced on November 15, 2010 that it had entered into a pro forma transfer of control agreement under which Rocco B. Commisso, the founder, Chairman and Chief Executive Officer of Mediacom, would purchase all of the outstanding shares of Mediacom common stock not owned by Mr. Commisso for \$8.75 per share in cash. Prior to the stock transfer, Mr. Commisso owned 40% of the stock of the company, and controlled 87% of the voting interest of all common stock. This transaction has now taken place and Rocco B. Commisso is the sole owner of Mediacom.

It is the parties' understanding that Commission approval is not required for this transaction. Therefore, this letter is submitted for informational purposes only to ensure the accuracy of the Commission's records.

Mediacom provides voice services in Florida through its certificated subsidiary, MCC Telephony of Florida, LLC (herein "MCC"). No change in ultimate control of MCC has occurred as a result of the transaction. The transaction did not and will not impact the operations of MCC, the certified entity. MCC will remain the certificated entity providing telephone service in Florida. Moreover, MCC, as it is today, will remain a subsidiary of Mediacom Communications Corporation.
