Dear Ms. Cole:

The purpose of this letter is to request cancellation of CLEC Certificate No. 8452 held by SBC Long Distance, LLC d/b/a SBC Long Distance d/b/a AT&T Long Distance. In accordance with Rule 25-24.820, Florida Administrative Code, SBC Long Distance, LLC states the following:

- 1) CLEC Certificate No. 8452 is being cancelled because the company no longer has any local customers. The last customer was terminated in November 2010. Accordingly, the customer notice requirement is inapplicable.
- 2) The company does not currently hold any customer deposits and has no outstanding bills for service from customers.
- 3) SBC Long Distance, LLC has submitted its final regulatory assessment fee payment due on or before January 31, 2011.

Based on the foregoing, SBC Long Distance, LLC d/b/a SBC Long Distance d/b/a AT&T Long Distance respectfully requests that Certificate No. 8452 be cancelled.

Additionally, SBC Long Distance, LLC d/b/a SBC Long Distance d/b/a AT&T Long Distance respectfully requests that its F.P.S.C. Price List No. 4 and its F.P.S.C. Price List No. 3 be withdrawn concurrent with the cancellation of Certificate No. 8452.

SBC Long Distance will continue to offer long distance voice and data services and is therefore not cancelling its Certificate No. 5210 (Interexchange Carrier Registration No. T1684).
