Please accept this letter as an informal status report for the aforementioned dockets. Progress Energy Florida, Inc. ("PEF") is recently in receipt of the letter dated March 30, 2011 sent by Hathaway Renewable Energy, Inc. ("Hathaway") to the FPSC.

Prior to receipt of this letter PEF was unaware of Hathaway's positions on the several issues that they discuss in that letter. Soon after the Staff issued its recommendations in the above-listed dockets, PEF revised the three (3) negotiated contracts with Hathaway using the then recent 2010 avoided cost data and PEF sent these revised contracts to Hathaway. Those revised contracts were pending approval and signature by Hathaway, but based on Hathaway's March 30, 2011 letter, PEF is unsure whether Hathaway intends to continue negotiations. Should PEF and Hathaway agree on any revised negotiated purchase power contracts, PEF will provide notice to the Commission.
