
3. Pursuant to the requirements in this docket, Indiantown, concurrently with the filing of this petition, files testimony and conservation cost recovery true-up schedules (Exhibit JVH-1) for the period, consisting of the CT schedule reporting forms supplied by the Commission Staff.
4. As indicated in the testimony of Mr. Jason Van Hoffman, for the period January 2010 through December 2010, the Company over-recovered \$17,000, as compared to its estimated

over-recovery of \$10,169, resulting in an adjusted end of period total true up amount of \$6,831.

WHEREFORE, Indiantown respectfully requests that the Commission enter an Order approving the Company's final natural gas conservation true-up amount for the period January 1, 2010 through December 31, 2010.


