Anna:

AUF has reached a tentative agreement with Bonita Springs Utilities (BSU), an entity exempt from FPSC jurisdiction. BSU is currently conducting its due diligence and is working with the HOA for possible acceptance of the irrigation system. BSU and AUF expect to have a final resolution within the next 5 - 6 months. Additional time is requested in order to get the appropriate approvals, including approvals from the HOA and BSU.

Once the agreement is finalized and approved, AUF expects to file a notification and necessary documents with the FPSC in order proceed with an acknowledgement of sale.
