**SECOND NOTICE OF INTENT TO REQUEST  
CONFIDENTIAL CLASSIFICATION**

Progress Energy Florida ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Confidential Classification of portions of its responses to the Office of Public Counsel's ("OPC") Fourth Set of Interrogatories (Nos. 33-60), specifically the responses to interrogatory 36, certain documents produced in response to interrogatory 55 and certain documents produced in response to OPC's Fourth Request for Production of Documents (Nos. 20-26), specifically numbers 21, 23 and 26 (collectively, the "responsive information"). Portions of the responsive information contain PEF's confidential competitive business information, as well as confidential information received from third-party vendors pursuant to contractual agreements, the release of which would harm PEF's competitive business interests and violate contractual non-disclosure agreements. Therefore, PEF is requesting that the Commission afford these documents confidential classification.
