On March 8, 2011, Master Call Corporation filed an IXC Registration Form and a tariff with this Commission. The company also requested acknowledgement of cancellation of IXC Registration No. TJ788. By letter dated June 27, 2011, Mr. Ross Tsoutiev, President of the company, requested withdrawal of Master Call Corporation's IXC registration and tariff. Pursuant to the Regulatory Reform Act, on July 1, 2011, this Commission will no longer regulate IXCs; therefore, IXC Registration No. TJ788 will be cancelled as of midnight June 30, 2011.

Staff has determined that no pending issues need to be addressed by the Commission and no agency action has been taken. Pursuant to Section 2.07.C.2.d(4) of the Administrative Procedures Manual, staff requests that this docket be closed administratively.
