

The PSC Staff has asked that I file an update on the status of Colina Recovery, Inc.'s intentions regarding the transfer of this water certificate. The current intention is for Colina Recovery, Inc. to transfer the water system to the Colina Bay Homeowner's Association, Inc., which would render the water system exempt from PSC regulation pursuant to the provisions of Section 367.022(7), Florida Statutes.
