BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida") pursuant to Rule 25-22.006, Florida Administrative Code, hereby files its Motion for Extension of Duration of Order No. PSC-10-0040-CFO-TL, Granting Confidential Classification, and states as grounds in support thereof the following:

1. On January 15, 2010, the Florida Public Service Commission (the "Commission") issued Order No. PSC-10-0040-CFO-TL, granting AT&T Florida's Request for Specified Confidential Classification of Document No. 03443-09.
2. The reasons AT&T Florida asserted in support of confidential treatment in its original Request for Specified Confidential Classification remain. Specifically, there remains a need to protect proprietary business information and competitive interests which are not subject to public disclosure.
3. The information requested remains in the possession of the Commission.
4. For the reasons set forth above, and in AT&T Florida's original Request for Specified Confidential Classification, AT&T Florida hereby requests that the Commission enter an order extending the period of confidential classification for an additional 18 months, or for any longer period of time that the documents remain within the possession of the Commission.
