**FOURTH NOTICE OF INTENT TO REQUEST  
CONFIDENTIAL CLASSIFICATION**

Progress Energy Florida ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Confidential Classification of portions of the Late Filed Exhibits of Mr. Jon Franke and Mr. John Elnitsky (collectively, the "Late Filed Exhibits"). Certain of the Late Filed Exhibits, specifically Late Filed Exhibit No. 6 and 7 from Mr. Franke's June 13, 2011 Deposition and Late Filed Exhibit No. 1 from Mr. Elnitsky's June 17, 2011 Deposition, contain PEF's confidential competitive business and strategic planning information as well as confidential contractual information, the release of which would harm PEF's competitive business interests and violate contractual non-disclosure agreements. Therefore, PEF is requesting that the Commission afford these documents confidential classification.

PEF is providing as Exhibit "A" a CD containing the confidential information in question.

Pursuant to Rule 25-22.006(3)(a)(1), PEF will file its Request for Confidential Classification for such confidential information contained therein within twenty-one (21) days of filing this request.
