NUCLEAR COST RECOVERY CLAUSE.

ISSUED: July 7, 2011

NOTICE is hereby given that the Florida Public Service Commission (FPSC) has received an emergency petition from Progress Energy Florida, Inc., filed on July 1, 2011, in Docket No. 110009-EI, seeking a variance from or partial waiver of Rule 25-6.0423(5)(c)(2) and (5), Florida Administrative Code (F.A.C.). Rule 25-6.0423, F.A.C., establishes alternative cost recovery mechanisms for the recovery of prudently incurred nuclear power plant costs consistent with Section 366.93, Florida Statutes. Rule 25-6.0423(5)(c)(2), F.A.C., requires the FPSC to conduct a hearing each year and determine the reasonableness of projected construction expenditures and associated carrying costs and to make an annual prudence determination of the utility's prior year's actual construction costs and associated carrying costs. Rule 25-6.0423(5)(c)(5), F.A.C., provides that a utility shall submit each year for FPSC review and
