HB 1231, which transferred wireless ETC designation authority from the Florida Public Service Commission (FPSC) to the Federal Communications Commission, became law on July 1, 2011. Since the FPSC no longer has wireless ETC designation authority, Cellco Partnership has withdrawn its petition. APM 2.07 provides that the Clerk may administratively close a docket upon the joint recommendation of the OPR division and Office of the General Counsel, including:
