Dear Ms. Cole:

On July 28, 2011, Equity LifeStyle Properties ("ELS") filed in this docket a motion to extend the time for submitting a Motion to Dismiss each Objection to the Proposed Utility and Petition For Formal Administrative Hearing ("Objection") filed on July 13, 2011, by, respectively, Pasco County ("County") and The City of New Port Richey ("City"). Per Rule 28-106.204(1), Florida Administrative Code, absent an extension of time, ELS's Motion to Dismiss was due on August 2, 2011. As a precaution, on August 2, 2011, ELS filed its Motion to Dismiss, but requested that it not be acted upon until the motion for extension of time had been ruled upon. ELS further stated in its Motion to Dismiss that, if the motion for extension of time were granted, ELS would withdraw the Motion to Dismiss and would refile it, as necessary, within the timeframe of any extension granted.

On Friday, August 5, 2011, the Commission issued an Order Granting Extension of Time which provides that, for good cause shown, ELS may have until September 15, 2011, to file its Motion to Dismiss. Order No. PSC 11-0333-PCO-WU. Due to the Prehearing Officer's August 5, 2011, Order granting ELS's request for extension of time, ELS withdraws the Motion to Dismiss it filed on August 2, 2011. In accordance with the Order Granting Extension of Time, ELS will file its Motion to Dismiss, if needed, by September 15, 2011.
