


From Tallahassee take I-10 to I-75 South.

Turn right on Jog Road then left on Melaleuca Lane.



Take exit 136 to merge onto FL-884 W/Colonial Blvd toward Ft Myers





In Sebring, turn right onto S Highlands Ave, then left onto South Commerce Avenue.



Turn right onto FL-434 E/Alafaya Trail





Turn left onto N 2nd St.








