

PLEASE TAKE NOTICE, that on September 6, 2011, or as soon thereafter as practicable, in the United States Bankruptcy Court, 271 Cadman Plaza East, Brooklyn, NY 11201, a Stipulation and Order will be presented for signature to the Honorable Carla E. Craig, Chief United States Bankruptcy Judge, settling the remaining claims and issues between and among Godot Soft, LLC, Joseph Pannullo (the "Claimants"), and the Liquidating Trustee, as more specifically set forth in the Stipulation and Order. The settlement essentially provides for the settlement of Godot Soft, LLC's remaining \$200,000 administrative claim against the Liquidating Trust (which is contingent upon events relating to the IRS which have occurred but remain subject to appeal) by paying such claim early at a discount. The terms and conditions are set forth in detail in the Stipulation and Order, a copy of which is available on the PACER website or upon request to counsel to the Liquidating Trustee, and to which interested parties are referred for the complete terms and conditions of the settlement.

PLEASE TAKE FURTHER NOTICE that, objections, if any, to the Stipulation and Order must be in writing and received in Judge Craig's chambers and by: McCarter & English,

LLP, and counsel to the Claimants not later than 4:00 p.m. on August 30, 2011. Unless objections are received by that time, the Stipulation and Order may be signed without any further notice.

PLEASE TAKE FURTHER NOTICE, that in the event any objections are timely served and filed, a hearing will be conducted by the Court and held by the Honorable Carla Craig, Chief United States Judge, in her courtroom in the United States Bankruptcy Court at 271 Cadman Plaza East, Brooklyn, NY 11201, on September 14, 2011 at 2:00 p.m. or at such other time as the Court determines.
