COMMISSION STAFF'S PRELIMINARY LIST OF ISSUES

For purposes of the Status Conference on September 14, 2011, the Staff of the Florida Public Service Commission files its proposed Preliminary List of Issues.

ISSUE 1: Did intervenors Greco, Smith, Mallon, Turner, Singel, Politte, and Will each provide sufficient evidence that his or her request for an irrigation meter was initiated prior to April 7, 2009, as required by Order No. PSC-09-0263-TRF-WU, issued April 27, 2009, in this docket?

ISSUE 2: If any or all of the intervenors submitted sufficient evidence to show they requested an irrigation meter, should East Marion Sanitary Systems, Inc. be required to provide irrigation meters to those intervenors at the prior tariff rate of \$70 per meter?

ISSUE 3: If the Commission requires East Marion Sanitary Systems, Inc. to provide irrigation meters to any or all of the intervenors at the prior tariff rate of \$70, how should those irrigation meters be configured?

ISSUE 4: If the Commission requires East Marion Sanitary Systems, Inc. to provide irrigation meters to the intervenors, what is the allowable time in which the Utility must install those irrigation meters?

ISSUE 5: What is the appropriate monthly charge for any irrigation meter installed for the intervenors as a result of this protest proceeding?

ISSUE 6: Should the Commission initiate a show cause proceeding to determine if East Marion should be fined up to \$5,000 per day for failure to provide service in its territory in a timely manner pursuant to Rule 25-30.310, Florida Administrative Code and Section 367.111, Florida Statutes?

ISSUE 7: Should this docket be closed?
