



Consumers' bank numbers sought in new phone scam

Consumer advocates and law-enforcement officials are sounding the alarm about a new phone scam targeting South Florida seniors involving con artists who falsely claim the government is issuing new

Medicare cards, then asking for their bank account numbers.

Lee Millman, a Medicare spokeswoman in the agency's regional Atlanta office, said there are no plans for new cards for the federal health care system serving 45 million seniors. Millman added that Medicare of-

ficials never collect personal information over the phone and that the card play also was reported in North Carolina recently.

The Florida Attorney General's Office said it also has received complaints about callers claiming to be from Medicare and asking for

personal information. Al Payne, who manages the attorney general's Seniors vs. Crime office in Delray Beach, said his program has had similar reports. "I heard it's going around," he said.

Marlene Myerson, of Lake Worth, told the Sun Sentinel she received a phone call from some-

one claiming to be from Medicare. "They said they were sending out new Medicare cards," Myerson said.

But when the caller then asked for information about Myerson's bank account number, saying it was required to get the card, she became

suspicious and hung up. Millman said it's not uncommon for a Medicare scam to make its way around the country. "Some (ploys) are very short-lived," she said. "They'll appear in one state, then pop up few states away, then maybe go away for a year and pop up again."
