On August 31, 2011, pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company (FPL) requested confidential classification of certain information contained in Hearing Exhibits 127 and 202 submitted in Docket No. 110009-EI.

Staff has reviewed FPL's confidentiality request. In staff's opinion, the request does meet the criteria for confidentiality contained in Section 366.093, Florida Statutes.
