On August 19, 2011, pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company (FPL) requested confidential classification of certain information contained in Hearing Exhibit 125 submitted in Docket No. 110009-EI.

Staff has reviewed FPL's confidentiality request. In staff's opinion, the request does meet the criteria for confidentiality contained in Section 366.093, Florida Statutes. Therefore, staff recommends approval of FPL's request for a period of ". . . at least an eighteen (18) months" of confidentiality of certain information included in Document No. 05916-11.
