Re: Docket No. 110272-EU, Joint petition for approval of a territorial agreement in Lake County between City of Leesburg, a Florida municipality and Sumter Electric Cooperative, Inc., a Florida Cooperative.

Dear Mr. Stone and Mr. Morrison:

By this letter, the Commission staff requests that the City of Leesburg and Sumter Electric Cooperative, Inc. provide responses to the following data requests concerning the Territorial Agreement.

1. The maps provided with the agreement are difficult to review. Pursuant to Rule 25-6.0440 (1) (f), F.A.C., please provide a Florida Department of Transportation General Highway County map which clearly shows the proposed boundary area between the parties as described in the territory description of the proposed territorial agreement. Also, please reflect any boundary line changes that reveal the differences between the proposed boundary, and the boundary considered in the previous agreement approved in Order No. 25079 to Docket No. 910624-EU. This map should also include any areas of service provided by other parties, such as Progress Energy Florida, Inc. (PEF).
2. Please state whether the proposed boundary between the two parties to the proposed territorial agreement coincides with the city limits of Leesburg.
3. Please state whether, as a result of the proposed territorial agreement, there are any areas within the city limits of Leesburg served by SECO.



4. Leesburg also has a territorial agreement with PEF. This agreement was approved by the Commission in Order No. 12289 to Docket No. 820492-EU. Please state whether PEF has been apprised of the proposed territorial agreement, and whether PEF has any objections.
5. Please state whether the proposed territorial agreement in any way affects or alters the existing territorial agreement between PEF and Leesburg. If so, describe the manner in which the proposed agreement affects or alters the PEF/Leesburg agreement.
6. Please state whether the service locations of the two customers to be transferred from SECO to Leesburg, are within the city limits of Leesburg.
7. Paragraph 6 of the Joint Petition states that the transfer of customers will be completed within 18 months. However, Section 4.1 of the proposed territorial agreement and the customer notices in Composite Exhibit "C" to the agreement, state that the transfer of customers is to occur within 36 months or 3 years. Please explain the discrepancy between the two dates.
8. Please state the parties' intentions regarding customer deposits and provide assurances that the customers to be transferred will suffer no hardship as a result of the transfer.
