On October 10, 2011, Peninsula Pipeline Company (Peninsula) filed its request for confidential classification for Document No. 08014-11. The document contains the response to Staff's Second Data Request No. 4 and contains specific cost information developed in the context of providing a proposal for service to Florida Public Utilities Company for extending gas service into Nassau County. Staff has reviewed the document and concurs with Peninsula that the nature of the information meets the requirements set forth in Section 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would harm Peninsula's competitive business operations.

Therefore, staff recommends that FPUC's request for confidential classification of Docket No. 08014-11 be approved.
