Dear Ms. Cole:

Docket No. 080271-EI was opened to monitor the status of joint ownership discussions associated with Florida Power & Light's ("FPL's") Turkey Point Units 6 & 7, as directed in Order No. PSC-08-0237-FOF-EI, issued April 11, 2008.

By Order No. PSC-08-0237-FOF-EI, the Commission approved a stipulation which states in relevant part: "No later than July 1, 2009, FPL will continue its good faith discussions with FMEA, FMPA, and OUC, and will also commence good faith discussions of joint participation in Turkey Point Units 6 & 7 with JEA and Seminole. FPL will report the status of such ongoing status discussions to the FPSC every quarter thereafter."

As required by Order No. PSC-08-0237-FOF-EI, FPL has continued good faith discussions with the Florida Municipal Energy Association ("FMEA"), Florida Municipal Power Agency ("FMPA"), Orlando Utilities Commission ("OUC"), JEA and Seminole Electric Cooperative, Inc. ("Seminole").

FPL held a meeting on May 20, 2011 in Orlando, Florida. Representatives from FMPA, OUC, JEA, Seminole, Ocala Electric Cooperative and Homestead attended. This meeting was described in FPL's July 1, 2011 quarterly report. No meetings have been held since the meeting on May 20, 2011.
