



ISSUED: December 21, 2011

On April 12, 2011, an application was filed with the Florida Public Service Commission for approval to transfer the water assets and Certificate No. 428-W in Levy County from Par Utilities, Inc. to Hash Utilities, LLC.

Notice is hereby given that by Order No. PSC-11-0584-PAA-WU, issued December 21, 2011, in Docket No. 110098-WU, the Commission approved the transfer. In addition, the Commission approved Hash Utilities request to change the billing cycle from monthly to bi-monthly.

The change in the billing cycle will take affect with the January-February billing cycle. The rates will remain the same the bills will only come half as often. Your December bill will arrive on schedule and you will not receive a bill in January for January consumption. On February 25th you will receive a bill for the Jan-Feb cycle; this bill will include the January and February consumption amounts.
