2           **CHAIRMAN BRISÉ:** Now we will officially call  
3 the meeting to order. We have a gavel, I'm not sure if  
4 we're supposed to use it, but I guess I will for today.

5           I will ask for a motion for our Move Staff  
6 List at this point.

7           **COMMISSIONER EDGAR:** Mr. Chairman, I  
8 understand that we may have an oral modification on  
9 Item 4, is that true?

10          **MR. CICCHETTI:** Yes, Commissioner.

11          **COMMISSIONER GRAHAM:** Perhaps we should hear  
12 that.

13          **CHAIRMAN BRISÉ:** Okay. We will do that at  
14 this point.

15          **MR. CICCHETTI:** Good morning, Mr. Chairman,  
16 Commissioners. I'm Mark Cicchetti with Commission  
17 staff. Item 4 is staff's recommendation to suspend the  
18 final requested rates of Sanlando Utilities Corporation  
19 and to approve an interim increase subject to refund  
20 with interest. Staff has an oral modification related  
21 to the rates listed on Schedules 4A and 4B of the staff  
22 recommendation, which has been previously provided to  
23 yourselves and all parties. Staff is available to  
24 answer any questions.

25          **COMMISSIONER EDGAR:** Then, Mr. Chairman, with

1 that, if we are in the proper posture, I would move the  
2 staff recommendation on Items 1, 2, 3, 4 as modified,  
3 and 5.

4 **CHAIRMAN BRISÉ:** Give me one second.

5 Commissioner Balbis, did you have something prior to  
6 the motion or --

7 **COMMISSIONER BALBIS:** No. Prior to seconding  
8 that motion, I just would like to point out that there  
9 are two items on the Move Staff List that have to do  
10 with interim rates, and by statute and practice we are  
11 required to approve those while we have time to look at  
12 their applications closely and move forward with that.  
13 So with that I second the motion.

14 **CHAIRMAN BRISÉ:** Okay. At this time the  
15 motion has been moved and seconded. Are we ready for  
16 the vote? I suppose so, so all in favor say aye.

17 (Unanimous affirmative vote.)

18 **CHAIRMAN BRISÉ:** Very good. The motion  
19 carries. So that is Items 1 through 5 that have been  
20 taken care of or disposed of.
