2           **CHAIRMAN BRISÉ:** Now we will officially  
3 call the meeting to order. We have a gavel, I'm not  
4 sure if we're supposed to use it, but I guess I will  
5 for today.

6           I will ask for a motion for our Move Staff  
7 List at this point.

8           **COMMISSIONER EDGAR:** Mr. Chairman, I  
9 understand that we may have an oral modification on  
10 Item 4, is that true?

11           **MR. CICHETTI:** Yes, Commissioner.

12           **COMMISSIONER GRAHAM:** Perhaps we should  
13 hear that.

14           **CHAIRMAN BRISÉ:** Okay. We will do that at  
15 this point.

16           **MR. CICHETTI:** Good morning, Mr.  
17 Chairman, Commissioners. I'm Mark Cicchetti with  
18 Commission staff. Item 4 is staff's recommendation  
19 to suspend the final requested rates of Sanlando  
20 Utilities Corporation and to approve an interim  
21 increase subject to refund with interest. Staff has  
22 an oral modification related to the rates listed on  
23 Schedules 4A and 4B of the staff recommendation,  
24 which has been previously provided to yourselves and  
25 all parties. Staff is available to answer any

1 questions.

2           **COMMISSIONER EDGAR:** Then, Mr. Chairman,  
3 with that, if we are in the proper posture, I would  
4 move the staff recommendation on Items 1, 2, 3, 4 as  
5 modified, and 5.

6           **CHAIRMAN BRISÉ:** Give me one second.  
7 Commissioner Balbis, did you have something prior to  
8 the motion or --

9           **COMMISSIONER BALBIS:** No. Prior to  
10 seconding that motion, I just would like to point  
11 out that there are two items on the Move Staff List  
12 that have to do with interim rates, and by statute  
13 and practice we are required to approve those while  
14 we have time to look at their applications closely  
15 and move forward with that. So with that I second  
16 the motion.

17           **CHAIRMAN BRISÉ:** Okay. At this time the  
18 motion has been moved and seconded. Are we ready  
19 for the vote? I suppose so, so all in favor say  
20 aye.

21           (Unanimous affirmative vote.)

22           **CHAIRMAN BRISÉ:** Very good. The motion  
23 carries. So that is Items 1 through 5 that have  
24 been taken care of or disposed of.
