



AT&T FLORIDA’S MOTION TO MODIFY THE PROCEDURAL SCHEDULE

BellSouth Telecommunications, LLC d/b/a AT&T Florida (“AT&T Florida”), pursuant to Rule 28-106.204, Florida Administrative Code, hereby moves that the Prehearing Officer modify the procedural schedule established in the Order Establishing Procedure (Order No. PSC-12-0031-PCO-TP, hereinafter “Procedural Order”) issued in this Docket on January 19, 2012. AT&T Florida respectfully requests the Prehearing Officer to move the date of the hearing in the instant proceeding to May 1, 2012, or such other time from May 1, 2012 through May 4, 2012 as is convenient for the Commission. In support, AT&T Florida states:

1. The Procedural Order has established May 10, 2012 as the date for the evidentiary hearing in this case.
2. Subsequent to the issuance of the Procedural Order, a matter has arisen that requires the undersigned counsel for AT&T Florida to be out of the state during the time set for the hearing, thus preventing the undersigned counsel from attending the hearing. As a result, AT&T Florida respectfully requests that the Prehearing Officer modify the procedural schedule in this docket and set the date of the hearing in this docket for May 1, 2012, or such other time from May 1, 2012 through May 4, 2012 as is convenient for the Commission.


