E. Pursuant to Rule 25-6.0185, Florida Administrative Code, electric utilities that own or control electric generation facilities are required to file a long term energy emergency plan and periodic updates with the Florida Public Service Commission and the Florida Reliability Coordinating Council. The utilities are required to review their plans every three calendar years and either submit a revised plan to the Commission for approval or provide a letter indicating the adequacy of the existing plan. Pursuant to the Order for instructions regarding compliance of the next set of plans, Seminole Electric Cooperative, Inc. hereby submits a cover transmittal letter and its revised plan in both a clean and a type-and-strike (redline) versions as required by the Public Service Commission. Other than formatting revisions, the only changes from our last emergency plan filing in 2009 are 1) to revise some of the position titles due to internal reorganization and 2) to reflect changes in Seminole's Member General Managers.
