Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Gulf Power Company requests confidential classification of certain highlighted information provided in its Form 423 filings for October and November, 2011, filed 1/05/2012 (FPSC Document No. 00074-12) and 1/31/2012 (FPSC Document No. 00637-12).

Staff has reviewed Gulf Power Company's confidentiality requests. In staff's opinion, the requests meet the criteria for confidentiality contained in Section 366.093, Florida Statutes.
