**NEW TALK, INC.'S WITHDRAWAL OF REQUEST TO TRANSFER  
CERTIFICATE AND RELINQUISHMENT OF CERTIFICATE**

New Talk, Inc. (New Talk) hereby withdraws its request to transfer its CLEC certificate to Telecom Ventures, LLC (Telecom Ventures) and relinquishes its Florida CLEC certificate. In support thereof, New Talk states:

1. New Talk is a CLEC which holds Certificate No. 8467. On August 9, 2010, New Talk filed a request to transfer Certificate No. 8467 to Telecom Ventures.

2. Due to changes in the marketplace which have occurred subsequent to New Talk's request to transfer, New Talk hereby withdraws its request to transfer its certificate to Telecom Ventures. Thus, no further action need be taken in this docket and the docket should be closed.

3. In addition, since, at this time, New Talk has no plans to serve any Florida customers, New Talk hereby relinquishes its Florida CLEC Certificate No. 8467. Thus, no further action need be taken in this docket and the docket should be closed.<sup>1</sup>

4. The Commission has taken no action in this docket and thus New Talk requests that this docket be administratively closed.
