

**AMENDED SECTION 63.71 APPLICATION OF MIDWESTERN
TELECOMMUNICATIONS, INC. TO DISCONTINUE SERVICE**

Midwestern Telecommunications, Inc. (“Midwestern Telecom” or “MTI”), by its counsel, hereby submits a complete amended application (“Amended Application”) seeking authorization pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. § 214(a), and Section 63.71 of the rules of the Federal Communications Commission (“Commission”), 47 C.F.R. § 63.71, to discontinue its provision of resold wireline local telephone services.¹

MTI submits this Amended Application in order to accurately reflect (1) the points of geographic areas of service affected, and (2) dates and methods of notice to all affected customers. This Amended Application does not change the fact that the impact on the public of the planned discontinuance will be minimal. There are only approximately 2,380 customers currently using the services to be discontinued and all affected customers have a wide range of other choices from which to obtain local telephone services.

In support of its Amended Application, Midwestern Telecom provides the following information:

2. Date of Planned Service Discontinuance (47 C.F.R. §§ 63.71(a)(2); (b)(2)):

Subject to the Commission's authorization to discontinue service pursuant to Section 63.71(c) of the Commission's rules, effective on or after March 23, 2012, MTI will discontinue its service.

3. Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3), (b)(2)):

Subject to the Commission's authorization, MTI will discontinue service in Alabama, California, Florida, Georgia, Illinois, Indiana, Kentucky, Michigan, Mississippi, North Carolina, Ohio, Oregon, South Carolina, and Wisconsin.

4. Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(4), (b)(2)):

The affected services are resold wireline local telephone services. Specifically, MTI provides wireline telecommunications services to customers by reselling the service of the incumbent local exchange carrier, in most cases, AT&T.

5. Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. § 63.71(b)(3)):

In accordance with 47 C.F.R. §63.71(a), Midwestern Telecom has notified all affected customers of the planned discontinuance. Specifically, MTI sent notification letters via first class U.S. Mail to each of the affected residential customers in Alabama, California, Florida, Georgia, Illinois, Indiana, Michigan, Mississippi, Ohio, and South Carolina on January 5, 2012. MTI sent notification letters to its affected residential customers in Wisconsin on January 30, 2012. In addition, on January 26, 2012, MTI sent notification letters to its residential customers in Michigan which were revised to conform to Commission rules.

MTI sent a notification letter to its largest affected business customer's headquarters office, which is located in Oregon, on January 18, 2012, providing notice that MTI was discontinuing business line services to that customer. On February 16, 2012, MTI sent a revised notification letter to its largest affected business customer's headquarters in Oregon specifying that MTI was discontinuing business line services to that customer in all states in which that customer received service – Alabama, California, Florida, Georgia, Illinois, Indiana, Kentucky, Michigan, North Carolina, Ohio, and Wisconsin. MTI sent a notification letter to its other business customer, located in Illinois, on January 5, 2012.

In the notice letters, MTI provided customers with a toll-free number to an MTI customer service representative to answer any questions regarding the letters. Sample notification letters for each state in which service is to be discontinued is attached to this Amended Application as Exhibit A.

As required by Section 63.71(a) of the Commission's rules, copies of this Amended Application are being sent via first class U.S. Mail to the governor and public utility commission for each impacted state, as well as to the Special Assistant for Telecommunications at the

Secretary of Defense. A service list is attached to this Application as Exhibit B.

6. Regulatory Classification of Carrier (47 C.F.R. § 63.71(b)(4)):

Midwestern Telecom is a non-dominant carrier with respect to the services to be discontinued.

CONCLUSION

WHEREFORE, Midwestern Telecommunications, Inc. respectfully requests that the Commission authorize the proposed discontinuance of service on or before March 23, 2012.
