Marguerite, Tiffany,

At the 2/14 agenda conference the Commission voted to closed docket 090430-TP but directed staff to continue to monitor the rejection rate of CLEC orders through the LEX ordering system to determine what if any action should be taken by the PSC to improve rejection rates. This ongoing responsibility is to be docketed under existing docket 100121A-TP. Confidential documents filed by AT&T in response to staff data requests in docket 090430-TP are of continuing relevance to this ongoing responsibility and should be transferred to docket 000121A-TP.
