Please be advised that R.A.M. Golf Management, LLC (RAM) is in receipt of your “non-binding, informal opinion” proposed PSC resolution letter dated March 12, 2012 regarding RAM’s May 9, 2011 four point complaint against its non-potable water provider Aquarina Utilities, Inc. (AUI).

Please be advised your office’s proposed resolution is unacceptable for numerous reasons to RAM, therefore RAM will certainly request the PSC to use the entire package of RAM information attached to the May 9, 2011 complaint to make a binding, formal decision on this matter. Further, RAM has multiple complaints against AUI as evidenced in the May 9, 2011 complaint that were obviously omitted from any PSC resolution consideration within your March 12, 2012 resolution proposal, therefore a binding and formal decision is certainly necessary for all matters outlined in **complaint no. 1009000W** to succeed in any proposed PSC resolution acceptance.

Further, RAM believes that this PSC proposed resolution letter that RAM patiently awaited during the ten (10) months of PSC staff & leadership department turnover to receive is an inadequate review of the numerous facts stated as supporting points of the RAM matter. Currently, RAM is working under extreme duress caused by AUI’s lack of simple social & communication skills since its entry into the Aquarina community February 2011, mostly due to its principals continued threats of service termination, breaches of customer account status confidentiality, and now RAM staff “ARREST” should RAM touch any AUI owned distribution pipes that are “undefined” by AUI as of this writing. These continued uncooperative actions, together with your unacceptable initial proposed resolution mandate that RAM now protect itself via the Civil Court avenue(s) available to RAM within our States legal system.

This utility customer was very hopeful that the PSC would offer an agreeable resolution to the RAM V AUI matter, however the March 12, 2012 delivered PSC resolution proposal that tendered to RAM did NOT consider all the complaint matters, nor did it utilize the complete offering of the relevant facts in the matter to reach its proposed resolution. To say the March 12, 2012 letter was disappointing to RAM after all the time & effort extended in its complaint, is an understatement.

Please advise RAM of its next step within the PSC complaint / resolution process upon this written notification of our decision to demand a formal and binding PSC resolution in this matter.

Dear Ms. Hicks:

This law firm represents Aquarina Utilities, Inc., and has been asked to address the problematic issue that has just arisen regarding the above-referenced Complaint. As you know, this is a Complaint where the customer questions an invoice in the amount of \$18,875.99. Although this Complaint was filed in June of 2011, the matter does not seem to be close to being resolved. In accordance with Commission policy, during the Complaint process, Aquarina Utilities, Inc., has not discontinued service to the customer for nonpayment of the invoice that is in dispute.

The Utility has raised the concern regarding the ability to collect the past-due amount should the Commission determined it is entitled to it. Specifically, the Utility received an e-mail from the customer which included the reference that in a few months the customer would not continue to operate the golf course without financial support from the Community Association and its members. Thus, should R.A.M Management cease operating the golf course and, as a consequence, ceased being a customer of the Utility, the Utility's ability to collect the \$18,875.99 past-due amount is in jeopardy. Were it not for this Complaint, the Utility would have the ability to disconnect service to this customer, which is the primary leverage any utility has for collecting past-due accounts.

As a consequence of this dilemma, the Utility is requesting that the Commission require R.A.M. Management to immediately deposit in escrow the amount in dispute. If they fail to do so, then the Utility should be allowed to discontinue service. If the Commission were to ultimately determine that collection of the invoice was in error, it can order a refund. If it is determined that the Utility is entitled to the amount due, and R.A.M. Management is no longer a customer then all customers will shoulder this burden in the form of bad debt expense in any rate proceeding filed by the Utility. Obviously there is a
