2	CHAIRMAN BRISÉ: We're moving on to Item		
3	Number 6.		
4	MR. GARL: Thank you, Mr. Chairman.		
5	Commissioners, I'm Steve Garl with Commission		
6	staff. Item 6 is FPL's petition requesting approval of		
7	a revised standard offer contract and associated		
8	tariff. FPL's request was prompted by the filing of a		
9	need determination for the Everglades Power Plant that		
10	you considered in the previous item.		
11	Upgrading the Everglades plant changes FPL's		
12	next avoided unit from one with an in-service date of		
13	2016 to a new plant in 2021. Payments for energy and		
14	capacity in the standard offer contract, therefore,		
15	should be revised. Staff recommends that the		
16	Commission approve the revised standard offer contract		
17	and associated tariff. Staff is available for any		
18	questions you may have.		
19	CHAIRMAN BRISÉ: All right. Any questions?		
20	Commissioner Balbis.		
21	COMMISSIONER BALBIS: Thank you, Mr.		
22	Chairman.		
23	I just have one question for staff. In		
24	reviewing the details in the standard offer contract it		
25	appears that the unit is similar to the Port Everglades

unit that was the 2016 avoided unit; is that correct? 1 MR. GARL: Yes, Commissioner, that is 2 correct. 3 COMMISSIONER BALBIS: And compared to the 4 2016 avoided unit, the financial terms, whether it's 5 the capacity payment or the energy payment, has it 6 increased somewhat, or decreased, or remained the same? 7 MR. GARL: It has been shifted. It has been 8 increased due to the additional time between now and 9 the new avoided unit coming in service in 2021. 10 COMMISSIONER BALBIS: So an independent power 11 producer that takes advantage of the standard offer 12 contract or negotiated contract, this revised one or 13 this latest one, if we approve it, would receive higher 14 fuel or higher energy payments and higher capacity 15 16 payments? MR. GARL: Slightly higher, yes, in the out 17 years. Of course brought back to, comparing it to the 18 net present value of 2011 prices. 19 20 COMMISSIONER BALBIS: Okay. That's all I had. 21 CHAIRMAN BRISÉ: All right. Seeing no other 22 lights, I'm ready to entertain a motion. 23 COMMISSIONER BALBIS: Mr. Chairman, I would 24 move approval on staff's recommendation on these 25 FLORIDA PUBLIC SERVICE COMMISSION
