Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company (FPL) requested confidential classification of certain information included in its MFRs D-2 and F-4. This recommendation addresses the portion of FPL's request for confidential treatment of portions of MFR F-4.

Staff has reviewed FPL's confidentiality request. In staff's opinion, the request does meet the criteria for confidentiality contained in Section 366.093, Florida Statutes. Therefore, staff recommends that the request for confidentiality of certain MFR F-4 information included in Document No. 01648-12 be approved.
