

**AT&T FLORIDA'S NOTICE OF WITHDRAWAL OF ITS
NOTICE OF INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION**

BellSouth Telecommunications, LLC d/b/a AT&T Florida ("AT&T Florida"), by and through its undersigned counsel, respectfully files this notice withdrawing its Notice of Intent to Request Specified Confidential Classification ("NOI") for DN 02541-12, and states the following:

1. On April 23, 2012, AT&T Florida served its Responses to the Staff of the Florida Public Service Commission's ("Staff's") First Set of Interrogatories (Nos. 1-12), dated April 2, 2012, along with a NOI.
2. AT&T Florida's response to Interrogatory No. 1 of Staff's First Set of Interrogatories included a document that contains customer specific business information that may be considered confidential and proprietary to Express Phone. The Clerk of the Commission identified this information as DN 02541-12.
3. Today, Staff notified AT&T Florida that Express Phone has waived confidentiality and will not be filing a Request for Specified Confidential Classification for DN 02541-12.
4. Accordingly, based upon the foregoing, AT&T Florida hereby withdraws its NOI dated April 23, 2012 for the information in DN 02542-12.
