MOTION TO WITHDRAW APPLICATION WITHOUT PREJUDICE

COMES NOW, Image Access, Inc. d/b/a NewPhone (“NewPhone”) before the Florida Public Service Commission (“FPSC” or the “Commission”), by and through its President, and respectfully moves to withdraw, without prejudice, its Application for Certification as an Eligible Telecommunications Carrier, which was filed in the above-captioned docket on August 5, 2008. On April 19, 2012, NewPhone filed a notice with the Commission in FPSC Docket No. 120124-TX, informing the Commission that NewPhone will discontinue providing services in the State of Florida, which proposed discontinuance is expected to occur between June 19, 2012 and July 18, 2012. NewPhone’s proposed discontinuance of service is being accomplished without surrender or cancellation of its telecommunications authorization.

WHEREFORE, Image Access, Inc. d/b/a NewPhone respectfully requests that its Application for Certification as an Eligible Telecommunications Carrier in the above-referenced docket be withdrawn, without prejudice, and that this docket be closed.
