Dear Chairman Brisé:

This letter, pursuant to Rule 25-30.430, Florida Administrative Code, requests approval of a test year for Pluris Wedgefield, Inc. (the "Company"). The Company intends to submit an application for general rate relief to the Florida Public Service Commission for its water and wastewater systems located in Orange County, Florida. The Company intends to submit the minimum filing requirements ("MFRs") on or before July 1, 2012.

The Company has never had a rate case since it acquired these systems on November 18, 2009. The last rate proceeding for the water system was in Docket No. 070694-WS utilizing a test year ending June 30, 2007, which resulted on Order No. PSC-08-0827 PAA-WS, issued December 22, 2008. Wastewater rates were last set in a rate case that culminated in Order No. 20270 issued November 7, 1988.

The Company requests a historic test year ending December 31, 2011. The Company acquired the utility assets in late 2009, and 2010 served as a transition year from the prior owners. Calendar year 2011 is representative of the Company's current operations.

Within the last 18 months, there have been several plant improvements at both the wastewater and water treatment facilities of which the total combined amount is less than \$300,000.

Pro forma plant additions to the test year are estimated at less than \$100,000 and involve recent improvements to the water treatment plant finish water distribution system at the facility.
