Here are a few highlights though:

Filings submitted by electronic transmission must be attached to an e-mail sent to [filings@psc.state.fl.us](mailto:filings@psc.state.fl.us). Documents sent to any other Commission e-mail address will not be considered filed.

That the filing date for an electronically transmitted document shall be the date the Division receives the complete document. If the document is received on a non-business day, or after 5:00 p.m. on a business day, it will be considered filed as of 8:00 a.m. on the following business day.

That the Commission does not have the authority to grant an extension of time for certain jurisdictional filings, including motions for reconsideration and notices of appeal.

That the official copy of an electronically filed document is the copy printed by the Division upon receipt, document-stamped, and filed in the docket.
