**FLORIDA POWER & LIGHT COMPANY'S
MOTION FOR EXTENSION OF TIME**

Florida Power & Light Company ("FPL") moves the Commission for an extension of time until 5:00 pm on Monday, June 11, 2012 to file its Response in Opposition to the Office of Public Counsel's ("OPC") Motion to Compel FPL to Respond to Certain Interrogatories and Request to Produce Documents ("Motion to Compel").

1. On June 1, 2012 OPC filed its Motion to Compel. In accordance with Rule 28-106.204, F.A.C., FPL's Response in Opposition must be filed within seven days, so the response would be due on Friday, June 8, 2012. FPL and OPC are working to resolve OPC's concerns regarding the discovery that is the subject of OPC's Motion to Compel. FPL believes that considerable progress has been made toward a mutually agreeable resolution, but as of the date of this request no final resolution has been reached.

2. In order to allow additional time to reach resolution, FPL requests that it be permitted to file its Response in Opposition no later than 5:00 p.m. on June 11, 2012. FPL has conferred with OPC and has been authorized to represent that OPC has no objection to this request.

WHEREFORE, FPL respectfully requests an extension of time from June 8, 2012 to no later than 5:00 p.m. on June 11, 2012 within which to file its Response in Opposition to OPC's Motion to Compel.
