On October 31, 2011, Labrador Utilities, Inc. (the "Utility"), completed its application to the Florida Public Service Commission (the "Commission") for increased water and wastewater service rates, in which it requested a permanent revenue increase of approximately 45% for water service and approximately 25% for wastewater service.

By Proposed Agency Action Order No. PSC-12-0206-PAA-WS ("PAA Order"), issued April 19, 2012, the Commission proposed a revenue increase of 20.56% for water service and 1.2% for wastewater service. These increases were designed to allow the Utility the opportunity to recover its reasonable and prudent costs for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such water and wastewater service.

The increased rates and charges are effective for service on or after June 3, 2012.
