**MOTION TO ENLARGE THE GENERIC DOCKET REQUESTED BY UTILITIES,
INC. PURSUANT TO JOINT STIPULATION AND SETTLEMENT AGREEMENT
FILED IN DOCKET NO. 110153-SU**

The Office of Public Counsel ("OPC"), on behalf of the Citizens of the State of Florida, files this Motion requesting the Florida Public Service Commission ("Commission") enlarge the generic docket requested by Utilities, Inc. filed with the Commission on or about May 25, 2012.

In support of this Motion, OPC states:

1. On May 18, 2012, Utilities, Inc. and OPC ("Parties") entered into a Stipulation and Settlement Agreement in Docket No. 110153-SU resolving Utilities, Inc. of Eagle Ridge's Petition for a formal administrative hearing and OPC's Cross Petition concerning Proposed Agency Action Order No. PSC-11-0587-PAA-SU, issued December 21, 2011. The Joint Petition requesting approval of the Stipulation and Settlement Agreement was filed with this Commission on May 18, 2012, and is currently pending review and approval.

2. Pursuant to the terms of paragraph 1 of the Stipulation and Settlement Agreement, on or about May 25, 2012, Utilities, Inc. petitioned the Commission to open a separate generic docket to address certain issues raised in Utilities, Inc. of Eagle Ridge's Petition for formal administrative hearing in Docket No. 110153-SU related to the Utilities, Inc.'s Phoenix Project.

Pursuant to the terms of the Stipulation and Settlement Agreement, OPC agreed not to oppose that petition and the Utilities, Inc. agreed not to object to OPC petitioning to include additional generic issues for resolution as identified in the Stipulation and Settlement Agreement.

3. Pursuant to the terms of paragraph 1 of the Stipulation and Settlement Agreement, OPC requests the inclusion of additional generic issues raised by OPC that relate to the Phoenix Project and other issues which broadly relate to the issues raised in OPC's Cross Petition, in issue identification meetings in Docket No. 110153-SU, and any issues related to making and maintaining accounting and ratemaking adjustments in compliance with NARUC Uniform System of Accounts and prior Commission orders.

4. Pursuant to the terms of paragraph 1 of the Stipulation and Settlement Agreement, the Parties agree to meet informally with staff in a good faith effort to resolve or narrow the disputed generic issues. If the Parties are unable to resolve all the generic issues informally, the Parties will request that the remaining disputed issues be decided by the Commission in the generic docket.

5. Pursuant to the terms of the Stipulation and Settlement Agreement, the scope of the generic docket will likely encompass more issues than the one issue identified in Utilities, Inc.'s petition for a generic docket; therefore, OPC respectfully requests that the docket title be amended to reflect the nature of the expanded scope of issues as described in the Stipulation and Settlement Agreement.

6. In accordance with Rule 28-106.204(3), Florida Administrative Code, counsel for OPC consulted with counsel for Utilities, Inc. prior to filing this Motion, and is authorized to represent that Utilities, Inc. does not object to OPC's motion.

WHEREFORE, OPC respectfully requests the Commission to enlarge the generic docket requested by Utilities, Inc. in order to address the generic issues broadly identified in the Stipulation and Settlement Agreement entered into by the Parties on May 18, 2012.
