AT&T Florida has learned that Digital Express' June 5 letter was docketed as Docket No. 120169-TP.

Please be advised that AT&T Florida objects and does not consent to Digital Express' June 5 letter and asserts that the letter does not alter the effectiveness of the current Agreement between AT&T Florida and Digital Express, which was signed by both parties and approved by the Commission. AT&T Florida will file a formal response to Digital Express' June 5 letter in the near term.

We would appreciate if you would add AT&T Florida as a party of record to this docket.

¹ On June 5, 2012, Digital Express sent a different letter to AT&T Florida's Contract Management team in which it purported to notify AT&T Florida that it was unilaterally adopting New Talk's Florida interconnection agreement as of that date. Digital Express did not notify AT&T Florida that it was contemporaneously filing a notice with this Commission.
