**FLORIDA POWER & LIGHT COMPANY'S UNOPPOSED MOTION FOR EXTENSION OF TIME TO RESPOND TO WELLINGTON A. HOMEOWNERS ASSOCIATION INC.'S AMENDED COMPLAINT**

Florida Power & Light Company ("FPL"), pursuant to Rule 28-106.204, Florida Administrative Code, hereby moves for a one-week extension of time, through and including July 12, 2012, to file its response to Wellington A. Homeowners Association, Inc.'s ("Wellington HOA") Amended Complaint. In support of dismissal, FPL states:

1. On May 14, 2012, this Commission entered an order requiring Wellington HOA to amend its complaint within 30 days to include a more definite statement.
2. On June 14, 2012, Wellington HOA filed its Amended Complaint.
3. Pursuant to Rule 28-106.204, Florida Administrative Code, FPL must file its response to Wellington HOA's Amended Complaint by July 5, 2012.
4. Due to preexisting scheduling conflicts, FPL requires a reasonable extension of time. FPL requests one additional week, through and including July 12, 2012, to file its responsive pleading.
5. FPL conferred with counsel for Wellington HOA who has consented to the relief requested herein.
6. No party will be prejudiced by this extension.
