- A. No. Saturn primarily charged QCC its higher switched access price listed rates. Saturn
 did not disclose copies of all past and current off-price list arrangements to QCC. To
 QCC's knowledge Saturn has not provided QCC the same rates, terms or conditions
 received by the preferred IXC.


