PURPOSE AND PROCEDURE:

The purpose of this hearing is to consider the petitions and any motions or other matters that may be pending at the time of the hearing of Florida Power & Light Company and Progress Energy Florida, Inc. in Docket No. 120009-EI – Nuclear Cost Recovery Clause. The Commission may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on August 15, 2012. All witnesses shall be subject to cross-examination at the conclusion of their testimony.

This proceeding will be governed by Chapter 364 in addition to Chapter 120, Florida Statutes, and Rules 25-4, 25-9, 25-22, 25-24, 25-30, and 28-106, Florida Administrative Code.
