MS. EARNHART KINDLY FORWARDED OUR CORRECT CONTACT AND ADDRESS INFORMATION WITHIN THE PUBLIC SERVICE COMMISSION, AND CONFIRMED THE SAME TO ME. I AM CONFIDENT WE WILL HAVE NO ISSUES GOING FORWARD REMAINING IN COMPLIANCE WITH STATUTE AND REGULATION SINCE CORRESPONDENCE WILL COME DIRECTLY TO US IN THE FUTURE, RATHER THAN A THIRD PARTY.

I APOLOGIZE FOR THIS OVERSIGHT AND APPRECIATE THE ASSISTANCE OF THE COMMISSION IN HELPING US RESOLVE THIS ISSUES.
