- 8. Company understands that in accordance with the Florida Lifeline program, eligible customers will receive a \$12.75 monthly discount on their phone bill or equivalent minutes for wireless ETC's, \$3.50 of which is provided by the ETC, and \$9.25 of which is reimbursable from the Federal Universal Service Fund.
