

CUSTOMER NOTICE

ISSUED: JULY 24, 2012

On June 24, 2011, Utilities, Inc. of Eagle Ridge (the "Utility"), completed its application to the Florida Public Service Commission (the "Commission") for increased wastewater service rates, in which it requested a permanent rate increase of 24% for wastewater service.

By Proposed Agency Action Order No. PSC-11-0587-PAA-SU ("PAA Order"), issued December 21, 2011, the Commission approved a rate increase of 14.94% for wastewater service. These rates and charges were designed to allow the Utility the opportunity to recover its reasonable and prudent costs for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such wastewater service. The PAA Order was protested within the protest period by the Utility and by the Office of Public Counsel ("OPC"). The Utility and OPC subsequently entered into a Settlement Agreement that was approved by the Commission by Order No. PSC-12-0346-FOF-SU, which reaffirmed the rates set in the PAA Order.

The increased rates and charges are effective for service on or after July 29, 2012.

The rates prior to filing and the Commission-approved wastewater rates are attached to this customer notice.

This notice was prepared by the Utility and approved by the Commission Staff for distribution by the Utility to its customers.
