Q1. Please provide the name of the technician who performed the July 21, 2010 service call at Mr. Mauk's residence.

Response: Mr. Michael Nolan, Field Meter Technician.

Q2. At the July 21, 2010 service call, or at any other time, has Mr. Mauk's meter been tested for accuracy, and, if so, what were the results of the test(s)?

Response: On July 21, 2010, PEF tested Mr. Mauk's meter (meter number 1612179) at the premise address of 426 N. Virginia Ave, Deland, FL. The test results (FL100.07; LL 99.95; WA 100.05; Reading 63529) confirmed that the meter is functioning within the FPSC guidelines. Mr. Mauk was present for the meter test.

This same meter was set at Mr. Mauk's premise address on December 28, 2005. Prior to installation, a meter test was completed by the factory on December 6, 2005 (Results: FL100.08; LL 99.93; WA 100.05; Reading 00000).

Q3. Please have that technician provide an affidavit as to whether or not he replaced the meter at that residence during the July 21, 2010 service call.

Response: Please see Attachment A.

Q4. Also, if the meter has been replaced anytime since 2005, please provide the date and the reason for the replacement.

Response: The meter has not been replaced. The meter at Mr. Mauk's residence is the same meter that was installed on December 28, 2005.
