

4. Rule 25-22.0365, Florida Administrative Code currently provides the requirements to request an expedited proceeding and the specific timelines in which the expedited proceeding will take place if the request is granted. Those specific timelines were crafted to provide for the shortest reasonable times for the processing of expedited proceeding, if the Commission determined that such an expedited proceeding was necessary. The proposed amendments to the rule would eliminate the specific timelines for certain types of cases and force the schedule of the case to be determined by getting to the soonest available agenda without regard to established standards in the current rule. Any decision made by the Commission to alter the existing rule regarding expedited proceedings will necessarily affect the substantial interests of AT&T Florida.

WHEREFORE, AT&T Florida respectfully requests that the Commission grant the Company leave to intervene for all legal purposes in this docket.
